WHAT "SCIENCE" IS - and - WHAT SCIENCE ISN'T

"Science" / the root "-ology" = the "the study of" something

Goals include:

GOOD SCIENCE VS BAD SCIENCE


GOOD science, well done science, properly done science, is:

- Slow, methodical, painstaking, repetitive, costly, reproducible and predictive
- All about QUESTIONING!!!
- All about REPRODUCIBILITY if it's not reproducible, is it factual? Is it even real?

GOOD scientists study something by:

- Identifying every possible variable that can affect the outcome
- Running a series of tests/experiments, each one holding all variables constant except one – to see, in turn, how each variable affects the outcome
- Lather, rinse, repeat

SCIENCE IS ABSOLUTELY NOT ABOUT COMING TO A CONSENSUS!!!



SCIENCE & CONSENSUS ARE EXACT OPPOSITES!!!

"CONSENSUS" = GROUP THINK = "SCIENTISM" = IN ESSENCE, A CULT

"THE SCIENCE IS SETTLED" – IS ALL ABOUT NOT QUESTIONING & SHUTTING DOWN QUESTIONS...

When a group comes to a consensus, it's very easy to dismiss other views & other information, which could have potentially catastrophic results

Bad science is biased (sometimes deliberately), and can be misused – esp. by those with <u>ulterior</u> <u>motives</u>...




How is this an example of Bad Science???

IMPORTANCE OF DIGITAL/ELEC. DATA PRIVACY & SECURITY

Every provider has their own privacy and data "sharing" policy:

- Utilities (for example, City of Buffalo w/r to water)
- Cell phone service providers, cell phone apps, etc.
- Internet/broadband svc providers, WiFi svc providers, audio/video streaming svcs, etc.
- Etc., etc., etc.

These tend to be <u>lengthy policies filled with legalese that few (no???) end users read...</u>
WHICH THEY KNOW... I can't help but wonder if they RELY on us not informing ourselves...

These policies allow them to sell, share, "lease", etc., our data with other companies.

We can't use these services until we agree to THEIR terms...

What recourse do we have for abuse/misuse of our data & their privacy policies???

How can we even know if there's been abuse/misuse???

How are subsequent users of our data keeping our data private & secure???

Do these secondary, tertiary, etc., companies have agreements with the companies they get the data from???

What recourse do we have if these subsequent users engage in abuse/misuse???

How can we even know if these other companies engage in abuse/misuse???

<u>City of Buffalo</u> – no Policy, Resolution, or Ordinance found re. keeping our data private & secure (cityofbuffalowy.com; last accessed 12/06/24)

Who among us has a signed Agreement with the City with regard to keeping our data private & secure???

<u>Johnson County</u> - same (johnsoncowy.gov; last accessed 12/06/24) – NO ordinances found online at all

<u>State of Wyoming</u> – I did not conduct a thorough search – there are some statutes, but they're not very satisfactory

HOW OUR DIGITAL/ELECTRONIC DATA IS BEING GATHERED & USED

MANY appliances and other electronics are gathering & providing data re. our habits, needs, and uses, and even whether we're home or not...

- "Smart" meters, "smart" phones, "smart" appliances, "smart" homes, Ring doorbells, etc.
- Desktop & laptop computers, iPads, etc.
- Vehicles' electronics
- Apple watches
- Baby monitors
- etc., etc., etc.

ALL of these electronics can be HACKED, REPROGRAMMED, DELIBERATELY FRIED (for example, via malware overworking them), etc.

The data signals can be intercepted, or blocked The data held in the "cloud" (server farms) can be accessed



















<u>How do they know EXACTLY WHERE we're using water in our own</u> homes???

WHY do they want to know this???

Do we want anyone to know this level of detail???



Is 169 gallons in 1 week truly "wasteful", when typical 4-person households use around 300-400 gallons per day??? (sorry, I couldn't get it any clearer, but it's from one of M-F's videos)

THE BIAS IS BAKED INTO "AI"


As "Al" continues to proliferate, the biases will only grow larger, with quite possibly potentially catastrophic consequences

"AI" is being sold to us as:


- "The AI knows best it took every factor into consideration"

THESE GIANT CORPORATIONS WILL BE TAX EXEMPT IN WY!!!


